Responsibilities:

Oversee agronomy aspects for the production of organic pulse crops and heirloom grains for contracted growers in Montana and southern Saskatchewan.

Advise growers on many aspects of organic farming operations, including field preparation, seeding, growing season management, weed/disease/insect pest management, crop rotations, field scouting, harvesting, storage and handling, and organic management on large scale organic family farms

Conduct regular growing season farm visits to monitor crops and fields, advise growers, and to predict yields, seed quality, and harvest dates. Extensive multi-day travel during the growing season is required.

Maintain a farm/field/production data base and analyze the data to assist both growers and Timeless management in meeting their production, yield, and quality goals.

Take the lead for organizing and conducting company-sponsored field days, grower meetings, farm visits by major customers, etc.

Collaborate to create content for newsletters, information tools, and materials for growers on soil health, crop rotations, management practices pertinent to organic production, and transitioning conventional land to organic practices.

Provide contract and production information to the management team, and provide monthly written reports.

Develop and solidify grower network, including identifying additional organic growers for Timeless production.

Collaborate on creating and monitoring an annual budget for Agronomy/Grower Liaison line items.

Attend statewide and region-wide university research center field days, organic farm tours, organic industry conferences, and other meetings.
